Leon made a motion that all council members get a \$5.00 per meeting raise. Second by Freddie. Leon, Freddie, and Henry yes. Harold and Harry, no. Gabe and Frances, abstained. Motion passed.

Motion to adjourn by Leon, second by Gabe. Motion carried.
