

December 2, 1980

The Tontitown Town Council met in regular session December 2, 1980 at the City Hall with the following members present: Harold Bausinger, Mayor; Frances Franco, Rec.-treas.; Gabe Pianalto, Henry Piazza, Freddie Taldo and Leon Zulpo, all Aldermen. Harry Sbanotto, alderman was absent.

Minutes and financial reports were read and approved. Motion by Freddie, second by Gabe to authorize the Rec.-treas. to pay all bills up to \$250.00. Motion passed.

Preliminary census report was received. Head count is 564, and housing count is 212.

Motion by Leon, second by Freddie to use expected Revenue Sharing money for the Street Fund. Motion passed.

The Mayor reported that the doors will be changed to 7 ft. doors and new locks installed. Cost will be approximately \$1,286.00.

Report by Gabe from the fire department. Annual dues will be \$20.00 for 1981. Two new directors were elected, they are Joe Pianalto and Gene Baker.

There was discussion on unpaid final water bills. The council agreed that water meters should be disconnected when bills are two months overdue so the water department will not loose large amounts on one bill. Freddie made a motion to raise the meter deposits to \$25.00 and the meter taps to \$175.00 or the cost of the tap which ever is greater. This is to become effective January 1, 1981. Second by Gabe. Motion carried.

The Annual Christmas party was set for December 14, 1980 at Mary Maestri's.

Motion to adjourn by Freddie, second by Henry. Motion passed.
