

December 7, 1982

The Tontitown Town Council met in regular session December 7, 1982 at the City hall. Those present were: Harold Bausinger, Mayor; Frances Franco, rec.-treas.; Gabe Pianalto, Freddie Taldo, Leon Zulpo, Henry Piazza, and Harry Sbanotto, all aldermen.

Minutes and financial report were read and approved. Regular monthly bills were approved for payment. Also approved for payment were bills from Arkansas Municipal League for 1983 dues and Municipal League Defense Fund in the amount of \$402.95, and The Springdale News in the amount of \$50.40.

The 1983 operating budget for the Tontitown water department was presented for approval. Motion by Gabe, second by Henry to approved the budget as presented. Motion carried.

There was discussion on uses for revenue sharing money for 1983. Motion was made by Leon, second by Freddie, to allocate two payment periods to be used for water department equipment, one payment for park work and trees to be planted in the park, one payment period for park or roads. Motion carried.

The Mayor reported that the contract for the fire department building was signed November 18, 1982. It will take five or six weeks for delivery.

Bids for the work on the Russell road were opened. Bids were as follows: Glen Meyers, \$7,440.00; Paul McGuire, \$4,855.00; Webb Construction Co., \$4,600.00; Warren Cook Dozier Co., \$2,325.00, (this bid does not include any SE-2). Motion by Freddie, second by Leon to accept Warren Cook bid if the price of SE-2 does not bring the price over next lowest bid. Motion carried.

Notice was received for the Springdale Water Dept. that our water rates will increase from 64¢ to 73¢ per thousand in 1983. There was discussion on the possibility of a rate increase to our customers. It was decided to wait until the audit to see how things are going.

Gabe reported that the fire department does have insurance on the firefighters and board members.

Our Christmas party will be held December 12th. at Mary Maestri's at 6:30 P.M.

Motion to adjourn by Leon, second by Freddie. Motion carried.
