This proposal covers initial cost and will be a recurring expense to a degree.

*I am proposing a recurring uniform allowance at Cruse Uniforms and equipment in the amount of 200 dollars per year per fulltime Officer beginning in 2014. I would like to further by adding 100 dollars per year per Officer until it is capped at 400 dollars per year in 2016.

*Neighboring agencies such as Elm Springs have a 400 dollar uniform allowance that allows the Officers to buy pants, shirts, pants and uniform equipment such as leather gloves, boots, magazine pouches, etc. Larger agencies such as Springdale have a \$550 dollar per Officer account set up at Cruse. The accounts are monitored by the store manager and limited at my parameters, i.e. \$200. Once the limit is met, the Officer must pay out of pocket for further purchases.

*There will be a rule of buying at least one shirt and one pair of pants per year. This will leave approximately \$120 per full time Officer to replace worn or damaged items for 2014.

*Total recurring costs will be \$1200 for year 2014, \$1800 for 2015, and capped at \$2400 for 2016. This includes boot expenses per fiscal year in the total cost.
