

Ordinance No. 8

An Ordinance defining the limits of the Corporation.

Be it ordained by the Council of the Incorporated Town of Tontitown Arkansas;

- I That the limits of the Incorporated Town of Tontitown Washington County, Arkansas are and shall be as follows until hereafter changed by law; Beginning at the Southwest corner of Section No. Two (2) in Township No. Seventeen (17) North of Range No. Thirty-One (31) West and running thence East One and one-half ($1\frac{1}{2}$) miles to the Southeast corner of the Southwest quarter of Section No. One (1) in said Township and Range, thence North Eighty (80) rods, thence East One Hundred and Sixty (160) rods thence North Eighty (80) rods, thence East One Hundred and Sixty (160) rods to the center of Section No. Six (6) in Township No. Seventeen (17) North of Range No. Thirty (30) West; thence North One Hundred and Sixty (160) rods to the North line of said Section No. Six (6), thence West Eighty (80) rods, thence North Forty (40) rods thence West, One Hundred and Sixty (160) rods, thence South Forty (40) rods, thence West One Hundred and Sixty (160) rods, thence South Forty (40) rods, thence West One Hundred and Twenty (120) rods or to the middle of the South line of the Southeast quarter of the Southwest quarter (S.E $\frac{1}{4}$ of the S.W $\frac{1}{4}$) of Section No. Thirty-Six (36) in Township No. Eighteen (18) North of Range No. Thirty-One (31) West; thence North Eighty (80) rods, thence East Forty (40) rods, thence North Eighty (80) rods, thence West, One Hundred and Sixty (160) rods, thence South, One Hundred and Sixty (160) rods, thence West one mile to the Northwest corner of said Section No. Two (2); thence South One Mile to the place of beginning, embracing within the Corporate limits of said proposed Incorporated Town all of Section No. Two (2) in Township No. Seventeen (17) North of Range No. Thirty-One (31) West and all of said Section No. One (1) in same Township and Range except the South half of the said Section No. One (1) and all of the Northwest quarter of Section No. Six (6) in Township No. Seventeen (17) North of Range No. Thirty (30) West and the South half of the Southwest quarter of the Southwest quarter (S $\frac{1}{2}$, SW $\frac{1}{4}$, - SW $\frac{1}{4}$) of Section No. Thirty-One (31) in Township No. Eighteen (18) North of Range No. Thirty (30) West, and the South half of the Southeast quarter of the Southeast quarter (S $\frac{1}{2}$ of the SE $\frac{1}{4}$ of the SE $\frac{1}{4}$) of Section No. Thirty-Six (36) in Township No. Eighteen (18) North of Range No. Thirty-One (31) West and West half of the Southeast quarter of the Southwest quarter (W $\frac{1}{2}$ of the SE $\frac{1}{4}$ of the SW $\frac{1}{2}$) and the West half of the Southwest quarter (W $\frac{1}{2}$ of the SW $\frac{1}{4}$) and the Northeast quarter of the Southwest quarter (NE $\frac{1}{4}$ of the W $\frac{1}{4}$) of Section No. Thirty-Six (36) in Township No. Eighteen (18) North of Range No. Thirty-One (31) West.
- II All Ordinances in conflict herewith are hereby repealed and this Ordinance shall take effect from and after its passage, approval and publication.
