

Ordinance No. 35

An Ordinance to regulate traffic in the Incorporated Town of Tontitown, Arkansas.

Be it ordained by the Town Council of the Incorporated Town of Tontitown, Arkansas;

- I That hereafter it shall be unlawful for any person to drive any motor vehicle in excess of Twenty-Five miles per hour on any street in the Town of Tontitown, Arkansas.
- II That hereafter no motor vehicle shall be parked on any side-walk in the Town of Tontitown, Arkansas, and any automobile left unattended so that any part of the automobile extends over the side-walk shall be considered parked on the said side-walk.
- III No automobile shall be parked or left unattended so that any part of the said automobile protrudes in the said street so as to interfere with the normal flow of traffic along the said street.
- IV All vehicles parked on any street in the Town of Tontitown, shall be parked with the right hand side of the automobile nearest the curb and where parallel parking is provided for, the right hand side of the automobile shall not be further than 12" from the curb or side-walk and no part of the left hand side of the automobile shall interfere with the normal use of the street.
- V All persons parking on the streets of Tontitown shall observe the signs with reference to parallel or angle parking and no vehicle shall park in any zone in which parking is forbidden as indicated by signs erected by the Police Department.
- VI No vehicle shall park between the corner of Barrington Road and Highway 68 extending East on the North side of 68 to a large tree which is about on a line with the East side of the Church building: from the tree East all parking shall be angle parking. On the South side of Highway 68 East of Barrington Road all parking shall be parallel parking; all parking on Barrington Road South of Highway 68 shall be parallel parking and no vehicle shall be parked nearer than Twenty feet from the intersection of Barrington Road and Highway 68 at any of the four corners of the said intersection. Parking West of Barrington on Highway 68 and North of Highway 68 on Barrington Road shall be angle parking.
- VII Any person found guilty of violating any part of this Ordinance shall be fined from \$1.00 to \$10.00 for the first offense; from \$5.00 to \$15.00 for the second offense and from \$10.00 to \$25.00 for each offense thereafter.
- VIII All parts of this Ordinance and all Sections herein are declared severable and if any part of this Ordinance shall be declared unconstitutional the remaining part of the Ordinance shall not be affected thereby.
Whereas, there is an immediate necessity for adequate traffic rules and regulations on the streets of the Town of Tontitown Arkansas, and it is necessary for the public health, safety and convenience of the residents of the Town of Tontitown, an emergency is hereby declared and this Ordinance shall become effective from and after its passage and approval.
