## Ordinance No. 41

An Ordinance vacating certain streets and alleys in the Original Town of Tontitown, Arkansas.

WHEREAS, a petition was filed with the Town Council of the Town of Tontitown, Arkansas, on the 12th day of February, 1964, asking that the Town Council vacate and abandon the following described streets and alleys situated in the Original Town of Tontitown, Arkansas, towit:

- (a) Columbus Avenue from West Second Street to East Third Street.
- (b) East First Street from Pandini Avenue to the South line of the Original Town of Tontitown.
- (c) East Second Street from Pandini Avenue to the South line of the Original Town of Tontitown.
- (d) East Third Street from Bandini Avenue to the South line of the Original Town of Tontitown.
- (e) An East and West alley extending West from East Third Street to the Southwest corner of Lot 8, Elock 44 and the Northwest corner of Lot 15, Elock 44 of the Original Town of Tontitown and running through Flocks 42, 43 and a part of 44.
- (f) An East and West alley extending West from Barrington Road to West Fifth Street and running through Elocks 45 to 49 inclusive.
- (g) An East and West alley extending West from Parrington Road to West Fifth Street and running through Flocks 58 to 62 inclusive.
- (h) An East and West alley extending from West First Street to West Fifth Street and running through Elocks 26 to 29 inclusive.

WHEREAS, after due notices as required by law, the Council has at the time and place mentioned in the notice, heard all persons desiring to be heard on the question, and has ascertained that the streets and alleys hereinbefore described have heretofore been dedicated to the public use as streets and alleys herein described; that petitioners are the sole owners of the property abutting all said streets and alleys; and that public interest and welfare will not be adversely affected by the abandonment of said streets and alleys.

NOW, THEREFORE, EE IT ORDAINED by the Town Council of the Town of Tontitown, Arkansas:

I The Town of Tontitown, Arkansas, hereby releases, vacates and abandons all its rights, together with the rights of the public generally in and to the streets and alley designated as follows:

- (a) Columbus Avenue from West Second Street to East Third Street.
- (b) East First Street from Bandini Avenue to the South line of the Original Town of Tontitown.
- (c) East Second Street from Eandini Avenue to the South line of the Original Town of Tontitown.
- (d) East Third Street from Bandini Avenue to the South line of the Original Town of Tontitown.
- (e) An East and West alley extending West from East Third Street to the Southwest corner of Lot 8, Plock 44 and the Northwest corner of Lot 15, Elock 44 of the Original Town of Tontitown and running through Plocks 42, 43 and a part of 44.
- (f) An East and West alley extending West from Earrington Road to West Fifth Street and running through Flocks 45 to 49 inclusive.
- (g) An East and West alley extending West from Farrington Road to West Fifth Street running through Blocks 58 to 62 inclusive.
- (h) An East and West alley extending from West First Street to West Fifth Street and running through Placks 26 to 29 inclusive.
- II A copy of the Ordinance duly certified by the Town Recorder shall be filed in the office of the Recorder of the county, and recorded in the Deed Record of the county.
- III This Ordinance shall take effect and be in force from and after its passage.

The undersigned, being the sole and only owners of the lands abutting upon the hereinafter described streets and alleys, hereby submit their petition to the Town Council of Tontitown, Arkansas, to vacate said streets and alleys, and for their petition herein, state:

1. That the petitioners are the sole and only legal owners of the lands which abut upon the following described streets and alleys in the Original Town of Tontitown, Ar-

kansas.

- That a copy of a portion of the plat of the Original 2. Town of Tontitown, Arkansas is attached hereto and made a part hereof, as though set out herein word for word, and that the streets and alleys situated in said area which petitioners desire to close, are described as follows:
  - (a) Columbus Avenue from West Second Street to East Third Street
  - East First Street from Bandini Avenue to the (b) South line of the Original Town of Tontitown
  - East Second Street from Bandini Avenue to the (c) South line of the Original Town of Tontitown
  - East Third Street from Bandini Avenue to the South line of the Original Town of Tontitown
  - An East and West alley extending West from (e) East Third Street to the Southwest corner of Lot 8, Block 44 and the Northwest corner of Lot 15, Block 44 of the Original Town of Tontitown and running through Flocks 42, 43 and a part of 44
  - An East and West alley extending West from Barrington Road to West Fifth Street and runn-(f) ing through Flocks 45 to 49 inclusive
  - An East and West alley extending West from Barrington Road to West Fifth Street and running through Flocks 58 to 62 inclusive
  - An East and West alley extending from West First Street to West Fifth Street, and running through Flocks 26 to 29 inclusive.

That so far as is known by these petitioners, no other persons, firms or coprorations are abutting owners to said streets and alleys as above described.

4. That said streets and alleys as designated on the plat of said Original Town of Tontitown have not been open or

actually used by the public as streets or alleys for a period of five (5) years last past.
