P E T I T I O N

Comes now the undersigned petitioners, and for their petition to vacate a portion of Bandini Avenue as shown on the plat of Tontitown, Arkansas, respectfully state:

1. That the petitioners are the owners of property abutting upon the said Bandini Avenue.

2. That the said Bandini Avenue as reflected on the aforementioned plat is 80 feet in width, and that a 50 foot width would be sufficient and that it would be to the best interest of the Town of Tontitown, if said Bandini Avenue was reduced in width to 50 feet by the vacating of 15 feet of equal and uniform width off the north side thereof and the vacating of 15 feet of equal and uniform width off the south side thereof.

3. That a photostatic copy of the plat of Tontitown, as filed in the office of the County Recorder showing the said Bandini Avenue and the abutting lots and blocks thereon, is attached hereto.

WHEREFORE, the petitioners pray that the Town Council of the Town of Tontitown, Arkansas, after proper notice and hearing, vacate a portion of said Bandini Avenue as described above, with the portions so vacated to become the property of the abutting land owners.
