WHEREAS, there has been filed in the County Court of Washington County, Arkansas, a petition to annex to Tontitown, Arkansas, the following described real estate:

Part of Section 7, Township 17 North, Range 30 West; Part of Section 6, Township 18 North, Range 30 West, and Part of Section 12, Township 17 North, Range 31 West, and being described as follows, to-wit: Beginning at the Northwest Corner of Section 12, Township 17 North, Range 31 West, thence South One Half Mile; thence East One Fourth Mile; thence South to the West Right-of-Way of the K. C. & M. RR; thence Northerly along said West Right-of-Way of the K. C. & M. RR, to a point 440 feet South of the North line of the Northeast Quarter of the Southwest Quarter of said Section 12, Township 17 North, Range 31 West; thence East to the East line of said NE $\frac{1}{4}$ of SW $\frac{1}{4}$ of said Section, Township and Range; thence North to the Center of said Section, Township and Range; thence East $\frac{1}{4}$ Mile; thence South $\frac{1}{4}$ Mile; thence East $\frac{1}{4}$ Mile; thence North to the Southwest Corner of the North Half of the South Half of the Northwest fractional Quarter of Section 7, Township 17 North, Range 30 West; thence East One Half Mile; thence North One Eighth Mile; thence East to a point 5 $\frac{1}{2}$ rods West of the Southeast Corner of the Northwest Quarter of the Northeast Quarter of Section 7, Township 17 North, Range 30 West; thence North 65 rods; thence East to the center of the Public Road; thence Northerly along the center of the Public Road to the North line of the Southwest Quarter of the Southeast Quarter of Section 6, Township 18 North, Range 30 West; thence West to the Northwest corner of said SW $\frac{1}{4}$ of SE $\frac{1}{4}$ of said Section, Township, and Range; thence South $\frac{1}{4}$ Mile; thence West 1 $\frac{1}{2}$ Miles to the point of beginning.

AND WHEREAS, in the petition, Harry Sbanotto is nominated as the agent to carry out the wishes of the petitioners.

AND WHEREAS, notice has been duly published in the Springdale News, a legal newspaper in Washington County, Arkansas, calling on all those interested in the matter to appear either in support or opposition to the petition,


AND WHEREAS, the area sought to be annexed is susceptible to development, contiguous and adjacent to Tontitown, Arkansas,
