# ORDINANCE NUMBER \_\_103\_\_

AN ORDINANCE REQUIRING PLUMBING PERMITS FOR IMPROVEMENTS ON THE TONTITOWN WATER SYSTEM; TO DECLARE AN EMERGENCY AND FOR OTHER PURPOSES.

WHEREAS, the Town of Tontitown has allowed persons outside the corporate boundaries of the Town of Tontitown to hook on to the Tontitown water system; and

WHEREAS, the Town Council deems it necessary for the purpose of protecting the integrity and safety of the water system of the Town of Tontitown to require certain permits and inspections; and

WHEREAS, the Town Council deems it necessary for the purpose of promoting the health, safety, and general welfare of the citizens of the Town of Tontitown, Arkansas and those persons lying outside the Town of Tontitown, Arkansas on Tontitown water to require certain permits and inspections;

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL FOR THE TOWN OF TONTITOWN, ARKANSAS AS FOLLOWS:

#### SECTION I

Whenever an improvement is constructed beyond the corporate boundaries of the Town of Tontitown, which the owner desires to have on the Tontitown water system and for which permission is granted by the Town of Tontitown for such owner to hook onto the Tontitown water system, such owner shall be required to purchase from the Town of Tontitown a permit for plumbing (which includes gas lines) at a base cost of \$ 210.00 per permit plus the fees charged by the Town of Tontitown for plumbing and gas inspection fees as set forth in Ordinance Number 99 of the Town of Tontitown, Arkansas.

### SECTION II

The construction of the plumbing and gas lines of the owner desiring such permit shall conform to the requirements of the plumbing and gas codes required of citizens living within the corporate boundaries of the Town of Tontitown as enacted and amended from time to time. Furthermore, such owner shall be required to have such inspections as required by such plumbing and gas codes.

### SECTION III

In the event an owner who desires to have Town of Tontitown water does not comply with the terms and provisions of this Ordinance, then such owner shall be denied the right to hook on to such water system. Nothing contained herein, however, shall require the Town of Tontitown to allow owners outside the corporate boundaries to hook on to its water system.

## SECTION IV

All inspections must be ready when called for, and if an extra trip is necessary, there will be an additional minimum charge of \$ 25.00 for each additional trip. All inspections shall be called for well in advance as the City Inspector must plan his work in an efficient manner.

## SECTION V

It is hereby declared that an emergency exists and this Ordinance, being necessary for the preservation of the health, safety, and welfare of the citizens of the Town of Tontitown, Arkansas, shall become effective immediately upon its passage, approval, and publication.
