ORDINANCE NO. 117

AN ORDINANCE ENTITLED "AN ORDINANCE AMENDING ORDINANCE NO. 92, THE SAME BEING THE ZONING ORDINANCE OF THE CITY OF TONTITOWN, ARKANSAS, AND THE PLAT PERTAINING THERETO, AND THE CITY CODE OF ORDINANCES; FOR REZONING THE LAND DESCRIBED IN PETITION 042004A, THE PETITIONERS BEING ARDEMAGNI RENTALS; AND FOR OTHER PURPOSES."

WHEREAS, the Tontitown Planning Commission of the City of Tontitown, Washington County, Arkansas, gave notice as required by law and set a hearing date of April 20, 2004 for hearing the matter of redistricting the hereinafter described tract of real estate:
