

ORDINANCE NO. 189

AN ORDINANCE AMENDING ORDINANCE NO. 84 OF THE CITY OF TONTITOWN, ARKANSAS, DECLARING AN EMERGENCY, AND FOR OTHER PURPOSES

WHEREAS, on July 6, 1988, the Tontitown City Council passed Ordinance No. 84 for the purpose of establishing a system for naming streets, addressing property, and insuring continuity for further growth of the City, and

WHEREAS, on June 8, 2004, an election was held for the purpose of putting before the voters a proposed annexation of property into the City of Tontitown, which annexation was approved, a result of which has required the City to provide addressing of property which was previously not in the corporate limits of the City; and

WHEREAS, the aforementioned annexation has created a reconfiguration of the City boundaries such that the dividing lines as set forth in Ordinance No. 84 no longer provide the most logical division of the City for purposes of addressing property, and are inconsistent with the 911 Emergency addressing system;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TONTITOWN, ARKANSAS, AS FOLLOWS:

- 1. That Section 3.1 of Ordinance Number 84, entitled "Centerlines," shall be amended to read as follows:
- 3.1 Henri de Tonti Boulevard and its extension to City of Tontitown's East and West planning area boundary shall be the centerline street for North and South address numbers. Barrington Road and its intersection with Henri de Tonti Boulevard will be the center point for East and West address numbers. The South sector will be divided by South Barrington Road extending to the southern city limits and/or the Planning Area Boundary. The North sector will be divided by N. Barrington Road North to Liberty Avenue then West 420 feet, then due North to E. Baker Avenue, then West to Sabatini Road, following Sabatini Road to the Planning Area Boundary.
- 2. All other provisions of Ordinance 84 shall remain in full force and effect except to the extent that they are inconsistent with this Ordinance.

EMERGENCY CLAUSE: It is hereby declared that an emergency exists, and this Ordinance, being necessary for the health, safety, and welfare of the citizens of Tontitown, shall be effective immediately upon its passage, approval, and publication.
