## ORDINANCE NO. 2005-3-205

AN ORDINANCE ENTITLED "AN ORDINANCE AMENDING ORDINANCE NO. 92, THE SAME BEING THE ZONING ORDINANCE OF THE CITY OF TONTITOWN, ARKANSAS, AND THE PLAT PERTAINING THERETO, AND THE CITY CODE OF ORDINANCES; FOR REZONING THE LAND DESCRIBED IN PETITION 011805, THE PETITIONERS BEING MAESTRI ENTERPRISES LLC.

AND FOR OTHER PURPOSES."

WHEREAS, the Tontitown Planning Commission of the City of Tontitown, Washington County, Arkansas, gave notice as required by law and set a hearing date of October 19, 2004 for hearing the matter of redistricting the hereinafter described tract of real estate:

The rezoning from R-O Residential Office to I-1 Light Industrial, of areas of land contained within the property described as follows:

AND WHEREAS, after giving notice as required by law, the Tontitown Planning Commission of the City of Tontitown, Arkansas, held a hearing; and after hearing arguments for and against such rezoning; and the Tontitown Planning Commission feeling that the area described herein should be redistricted and changed from (R-O)-Residential Office to (I-1) – Light Industrial in that the purpose of the Zoning Ordinance would be more properly carried out by such redistricting; and that unless granted, citizens of Tontitown will suffer irreparable harm and damage, and will be substantially deprived of the use of their property.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL of the City of Tontitown, Arkansas:

SECTION 1: Ordinance No.92, the Amendments thereto, and the Zoning Plat pertaining thereto of the City of Tontitown, Arkansas and; The City Code of Ordinances are hereby amended by rezoning the hereinafter described tract of real estate from (R-O) Residential Office to (I-1) – Light Industrial:

SECTION 2: EMERGENCY CLAUSE: The City council determines that an emergency exists and this Ordinance, being necessary for the preservation of the health, safety, and welfare of the citizens of Tontitown, Arkansas, shall be in effect from and after its approval, passage, publication and the recording of a certified copy thereof with the Recorder of Washington County, Arkansas.

A part of the Southwest Ouarter (SW 1/4) of Section Six (6). Township Seventeen (17) North, Range Thirty (30) West of the Fifth Principal Meridian, Washington County, Arkansas, and being more particularly described as follows, to wit:

Commencing at the Northeast corner of the Southwest Quarter (SW 1/4) of said Section Six (6): thence North 89°54′00″ West - 1.059.10 feet; thence South 00°13′30″ West - 2.632.20 feet; thence North 89°54′00″ West - 1.386.30 feet; thence North 00°49′00″ East - 688.06 feet to the POINT OF BEGINNING; thence continue northerly along said line, a distance of 935.05 feet; thence South 89°46′30″ East - 300.02 feet; thence South 00°49′00″ West - 935.05 feet; thence North 89°46′30″ West - 300.02 feet to the POINT OF BEGINNING, and containing 5.4398 acres, more or less, and subject to any easements and/or rights-of-way, of record, if any.
