**AN ORDINANCE ESTABLISHING THE PROCEDURE FOR THE INTRODUCTION OF RESOLUTIONS AND ORDINANCES FOR THE CITY COUNCIL OF TONTITOWN, ARKANSAS.**

**WHEREAS**, The City of Tontitown is empowered by Arkansas Code Annotated §14-55-102 to adopt ordinances to provide the safety, health, comfort and convenience of the inhabitants of the City of Tontitown, Arkansas.

**WHEREAS**, the City of Tontitown has determined that it is in its best interest to establish by Ordinance, rules, procedures and guidelines for the introduction of resolutions and Ordinances before the City Council of Tontitown, Arkansas.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TONTITOWN, ARKANSAS, AS FOLLOWS:**


**Section 1:** Any Resolution or Ordinance to be discussed at the City Council meeting shall be first submitted to an alderman to be placed on the agenda.

**Section 2:** Any alderman wishing to place an item on the agenda shall submit said item at least ten (10) days prior to the occurrence of the next regular City Council meeting. Special meeting notices shall contain any Resolution and/or Ordinance if such item will be discussed at the special meeting.


**Section 3:** Once an item is on the agenda, the sponsoring alderman is responsible for moving the introduction of said item to the City Council for appropriate action.
