

ORDINANCE NO. 2006-01-245

**AN ORDINANCE AMMENDING ORDINANCE 2005-07-223 AND ESTABLISHING THE PROCEDURE FOR THE INTRODUCTION OF RESOLUTIONS AND ORDINANCES FOR THE CITY COUNCIL OF TONTITOWN, ARKANSAS.**

WHEREAS, pursuant to Ordinance 2005-07-223 approved July 5, 2005 and pursuant to Arkansas Code Annotated 14-55-102,

WHEREAS, the City of Tontitown has determined that it is in its best interest to amend ordinance 2005-07-223

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TONTITOWN, ARKANSAS, AS FOLLOWS:

Section 1: Any Resolution or Ordinance to be discussed at the City Council meeting shall be first submitted to an alderman to be placed on the agenda.

Section 2: Any alderman wishing to place an item on the agenda shall submit to the City Attorney for review said item at least three (3) days prior to the occurrence of the next regular City Council meeting. Special meeting notices shall contain any Resolution and/or Ordinance if such item will be discussed at the special meeting.

Section 3: Once an item is on the agenda, the sponsoring alderman is responsible for moving the introduction of said item to the City Council for appropriate action.
