

### ORDINANCE NO. 2006-03-253

# AN ORDINANCE ESTABLISHING SANITATION SERVICE; PRESCRIBING PENALTIES; DECLARING AN EMERGENCY AND FOR OTHER PURPOSES;

WHEREAS, it has been brought to the attention of the City of Tontitown City Council that an unsightly and unsanitary condition frequently exists, as concerning trash pickup, in the City of Tontitown and the City of Tontitown City Council desires to eliminate the unsafe and unsanitary condition; and,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TONTITOWN, ARKANSAS, AS FOLLOWS:

<u>SECTION I</u>: <u>Authorized Agent</u>. No person or business entity may empty garbage or trash receptacles for hire, or may convey or transport garbage or trash on the streets or roadways of the City of Tontitown as agents for hire, other than the Authorized Agent for the City of Tontitown.

SECTION II: The City of Tontitown, through its Authorized Agent, will collect trash, rubbish and the garbage at all residential housing units within the complete city limits of the City of Tontitown, Arkansas each week.

<u>SECTION III: Rates.</u> The rates to be charged for the sanitation services provided by Ordinance shall be in accordance with the agreement or agreements, as the case may be, entered into by the City of Tontitown and the Authorized Agent.

SECTION IV: Penalties. Any person or business entity violating any provision of this ordinance shall be fined in the sum of not less than \$10.00 and not more that \$500.00, or may be sentenced to imprisonment for not exceeding thirty days, or both. Each act of violation and each day upon which a violation occurs constitutes a separate punishable offense. Any person, business or other entity refusing or failing to pay any charge assessed pursuant to the provisions of this ordinance shall be guilty of a violation and punishable as set out in this section. In addition, if it is judicially determined that any person, business or other entity has refused or failed to pay any charge assessed pursuant to the provisions of this ordinance for a periods of more than sixty consecutive days, the city shall terminate the city water and other services to the property for which the charge was made. The fact that legal title to property is in any person, business or other entity is responsible for the payment of charges provided for in this ordinance. The fact that charges incurred were for services provided to a tenant, agent, or other person using the title holder's property, shall not be grounds for staying the termination of city services provided for in this section.

<u>SECTION V</u>: All ordinances and parts of ordinances in conflict herewith are hereby repealed. If this ordinance, or any part of it, is held to be invalid or unenforceable for any reason whatsoever, the remainder of the ordinance shall be valid and enforceable.

SECTION VI: Emergency Clause. It having been found that the City of Tontitown is concerned about the unsanitary and unsightly conditions that frequently exist in the City of Tontitown, it is hereby declared that an emergency exists and this ordinance, being necessary for the preservation of the health, safety and welfare of the citizens of Tontitown, shall be in force and effect beginning after its passage and approval.
