# AN ORDINANCE ACCEPTING THE FINAL PLAT OF GPJ SUBDIVISION, TO THE CITY OF TONTITOWN, ARKANSAS AND DECLARING AN EMERGENCY

### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TONTITOWN,

**ARKANSAS:** That whereas, there has been duly presented to the City Planning Commission of Tontitown, Arkansas, a plat of certain lands in the City of Tontitown, Washington County, Arkansas, being more particularly described as follows, to wit:

A PART OF THE NORTHEAST QUARTER OF THE NORTHWEST QUARTER OF SECTION 12, TOWNSHIP 17 NORTH, RANGE 31 WEST, WASHINGTON COUNTY, ARKANSAS, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE NORTHWEST CORNER OF SAID NORTHEAST QUARTER OF THE NORTHWEST QUARTER, THENCE N89°26'11"E A DISTANCE OF 1229.13 FEET, THENCE S15°10'37"W A DISTANCE OF 383.76 FEET, THENCE N87°52'13"W A DISTANCE OF 542.51 FEET, THENCE S00°12'02"E A DISTANCE OF 175.00 FEET, THENCE N89°47'58"E A DISTANCE OF 500.00 FEET, THENCE S15°10'37"W A DISTANCE OF 647.54 FEET, THENCE S13°57'30"W A DISTANCE OF 73.64 FEET, THENCE S09°38'08"W A DISTANCE OF 44.84 FEET, THENCE S04°37'09"E A DISTANCE OF 45.13 FEET, THENCE S01°55'00"E A DISTANCE OF 6.27 FEET, THENCE S89°00'14"W A DISTANCE OF 155.68 FEET, THENCE S88°04'08"W A DISTANCE OF 151.14 FEET, THENCE S89°23'06"W A DISTANCE OF 597.31 FEET, THENCE N00°02'59"E A DISTANCE OF 1319.98 FEET TO THE POINT OF BEGINNING, CONTAINING 29.81 ACRES MORE OR LESS.

THE ABOVE DESCRIBED 29.81 ACRE TRACT BEING SUBJECT TO THE RIGHT-OF-WAY OF BARRINGTON ROAD AND ANY EASEMENTS AND/OR RIGHTS-OF-WAY WHETHER OR NOT OF RECORD. AND SUBJECT TO PROTECTIVE COVENANTS.

**AND WHEREAS,** said Planning Commission has approved the plat as presented by petitioner, and has approved the dedication of streets, rights-of-way and utility easements as shown upon said plat and join with said petitioner in petitioning the City Council to accept the said Plat of GPJ Subdivision to the City of Tontitown, Arkansas.

**AND WHEREAS**, a hearing was held upon the acceptance of said plat by the City Planning Commission and that there appeared no protestants to the acceptance and dedication.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TONTITOWN, ARKANSAS, that the Plat of GPJ Subdivision as shown on the plat approved by the City Planning Commission, a copy of which is attached to this Ordinance and made a part hereof as though set out herein word for word, be and the same is hereby accepted by the City of Tontitown, Washington County, Arkansas, and the City hereby accepts for use and benefit to the public the dedications contained therein.

EMERGENCY CLAUSE: It is hereby declared that an emergency exists in that the owner of the property will be deprived of the full use and enjoyments of their property.
