AN ORDINANCE REPEALING ORDINANCE NO. 172
ENTITLED AN ORDINANCE ESTABLISHING A PARKS
AND RECREATION COMMISSION FOR THE CITY OF
TONTITOWN, ARKANSAS, DECLARING AN
EMERGENCY, AND FOR OTHER PURPOSES (PASSED
AUGUST 5, 2003) AND REPEALING ORDINANCE NO.
2005-3-202 ENTITLED AN ORDINANCE AMENDING
ORDINANCE NO. 172 IN ORDER TO ENACT AN
ORDINANCE ESTABLISHING A PARKS AND
RECREATION COMMISSION FOR THE CITY OF
TONTITOWN, ARKANSAS, DECLARING AN
EMERGENCY, AND FOR OTHER PURPOSES (PASSED
MARCH 1, 2005) AND TO ESTABLISH A PARKS AND
RECREATION COMMITTEE, FOR THE CITY OF
TONTITOWN, AND FOR OTHER PURPOSES

WHEREAS, the City Council has determined that it would be in the best interest of the City of Tontitown, Arkansas, to repeal Ordinance No. 172 (passed August 5, 2003) and Ordinance No. 2005-3-202 (passed March 1, 2005) and to create a Parks and Recreation Committee in order to promote the effective development, operation, and maintenance of those existing parks requires administrative oversight in order to best preserve and protect the assets of said parks, to create an atmosphere which is inviting to the public, and to address the development, operation and maintenance of future parks; and

WHEREAS, the needs so outlined above could be accomplished by the creation of a Parks and Recreation Committee for the City of Tontitown.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TONTITOWN, ARKANSAS, AS FOLLOWS:

<u>Section 1</u>: That Ordinance No. 172 (passed August 5, 2003) and Ordinance No. 2005-3-202 (passed March 1, 2005) are hereby repealed.

Section 2: That a Parks and Recreation Committee, for the City of Tontitown, is hereby established. The Committee shall consist of three (3) members with one (1) member from each ward and who shall be appointed by the Mayor and approved by the City Council for a term of one (1) year. At all times, the members of this Committee shall be Alderman in the Tontitown City Council. Vacancies on the Committee shall be filled in the same manner as appointments. Members whose terms have expired shall continue to serve until their replacement is duly appointed and approved.

<u>Section 3</u>: All Ordinances, parts of Ordinances, municipal code sections or parts thereof which are in conflict herewith are hereby repealed.
