

ORDINANCE NO. 2006-10274

AN ORDINANCE AMENDING ORDINANCE NO. 206, THE SAME BEING THE ORDINANCE REGULATING THE MEETINGS OF THE PLANNING COMMISSION OF TONTITOWN, ARKANSAS.

WHEREAS, the City Council of Tontitown, Arkansas determined that it would be in the best interest of the City of Tontitown to amend Ordinance No. 206, which was enacted to regulate the meetings of the Planning Commission.

WHEREAS, the City Council of Tontitown, Arkansas has determined that it would be in the best interest of the City of Tontitown that the power to regulate the meetings of the Planning Commission should remain within the City Council, however, limited power shall be bestowed upon the Planning Commission with regard to its meetings.

WHEREAS, the Tontitown City Council has prepared an ordinance amending Ordinance No. 206, the same being The Ordinance Regulating the Meetings of the Planning Commission of Tontitown, Arkansas.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TONTITOWN, ARKANSAS IN REGULAR SESSION ASSEMBLED AS FOLLOWS:

SECTION 1. Ordinance No. 206 of the City of Tontitown, being an ordinance providing for regulation of the meetings of the Planning Commission of Tontitown, Arkansas.

SECTION 2. Section 1 - of said ordinance No. 2026 is hereby amended to read as follows:

That the time for the regular meetings of the Planning Commission shall be on the 4th Tuesday of every month, beginning October 23, 2006, commencing at seven o'clock (7:00) p.m. If city business requires, the Planning Commission will meet on the second Tuesday commencing at seven o'clock (7:00) p.m. of each month to compensate for any overflow of city business matters. If the commission determines that an "overflow" planning commission meeting is necessary it shall be held on the second Tuesday of the following month by motion and approval by a majority of the commissioners present. If for any reason the City Council believes that city business requires the Planning Commission to meet twice a month, the City Council may, by motion approved by a majority of the council members present, require the Planning Commission to meet twice a month. If this requirement is established by the City Council it will remain in effect, and can only be removed by motion, and approved by a majority of the council members present. If a second monthly meeting is deemed necessary by the Planning Commission or City Council, said meeting shall be on the 2nd Tuesday of every month.

SECTION 3. All provisions of said ordinance No. 57, and all amendments thereof, not hereby amended shall remain in full force and effect.

SECTION 4. All provisions of said ordinance No. 57, and all amendments thereof, not hereby

amended shall remain in full force and effect.

SECTION 5. The City Council hereby determines that this Ordinance is necessary to provide for adequate review of any business submitted to the planning commission and that the passage of Ordinance is essential to protect the health, safety, and welfare of the public; that the immediate passage of this Ordinance is necessary to adequately accomplish these purposes. Therefore, and emergency is hereby declared to exist and this Ordinance being necessary for the public welfare shall be in full force and effect from and after its passage and approval.
