

RESOLUTION 2007-02-136

A RESOLUTION AMENDING THE TONTITOWN MASTER STREET PLAN TO ELIMINATE, FROM THE PLAN, A CERTAIN SECTION OF PIAZZA STREET

WHEREAS, after due notice as required by law, the Tontitown Planning Commission has heard all persons desiring to be heard regarding an amendment to the Tontitown Master Street Plan as adopted by Resolution No. 2006-09-134; and

WHEREAS, after thorough consideration of comments and views expressed by all interested persons, said Commission unanimously approved an amendment to said plan and has certified the adopted plan, as amended, for consideration of the City Council.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TONTITOWN, ARKANSAS:


SECTION 1. That an amendment to the Tontitown Master Street Plan, to remove from the plan, that portion of Piazza Road between Fletcher Drive and U.S. 412, as approved by the Tontitown Planning Commission, and recommended for City Council adoption, be and is hereby approved.

SECTION 2. That the Tontitown Master Street Plan, as amended pursuant to Section 1 above, a copy of which is attached hereto and made a part hereof, be and is hereby adopted.

SECTION 3. That Recorder-Treasurer shall file a duly certified copy of the Tontitown Master Street Plan, as amended, with the Washington County Circuit Clerk, and with the Washington County Planning Office.
