### AN ORDINANCE ACCEPTING THE FINAL PLAT OF TONTITOWN PLAZA, TONTITOWN, WASHINGTON COUNTY, ARKANSAS, AND THE DEDICATION OF STREETS AND EASEMENTS THEREIN, PROVIDING FOR THE EMERGENCY CLAUSE AND FOR OTHER PURPOSES
