**AN ORDINANCE ACCEPTING THE FINAL PLAT OF
TONTITOWN PLAZA,
TONTITOWN, WASHINGTON COUNTY, ARKANSAS, AND THE
DEDICATION OF STREETS AND EASEMENTS THEREIN,
PROVIDING FOR THE EMERGENCY CLAUSE AND
FOR OTHER PURPOSES**

WHEREAS, pursuant to the provisions of the Tontitown City Code the final plat of Tontitown Plaza, Washington County, Arkansas, has been submitted to the Tontitown City Council for approval; and

WHEREAS, After consideration, said City Council has accepted and approved said final plat and all streets and easements therein pursuant to the provisions of the Tontitown City Code.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TONTITOWN, ARKANSAS:

Section 1: The final plat of Tontitown Plaza, Tontitown, Washington County, Arkansas, as well as all dedication of streets and easements therein, should be and the same is hereby accepted and approved.

Section 2: That it is necessary to begin the project immediately and because of such an emergency is declared to exist and in order to protect the public peace, health, safety and welfare this ordinance shall be in full force and effect from the date of its passage and approval.
