ACCEPTING CERTAIN ANNEXED ROADS FOR CITY MAINTENANCE

WHEREAS, the County Road Department has identified roads in the said annexed areas that they were maintaining under the direction of the Washington County Court; and


WHEREAS, it is the desire of the Mayor and City Council that formal approval be given regarding City maintenance of said roads.


NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TONTITOWN, ARKANSAS:
