

ORDINANCE 2007-07-295

AN ORDINANCE REDISTRICTING CITY WARDS

WHEREAS, cities have a statutory responsibility to assign annexed lands to city wards, and to insure that wards are of substantially equal population; and

WHEREAS, the annexation of certain lands to the City of Tontitown, voted upon by the electorate in 2006, has been confirmed by the Washington County Circuit Court; and

WHEREAS, regional planning staff has conducted a demographic analysis of annexed areas, as well as the city's current wards; has recommended that redistricting be undertaken; and has prepared a redistricting plan for consideration; and

WHEREAS, Arkansas law vests city councils with apportionment and redistricting authority; and

WHEREAS, it is the desire of the City Council, that the redistricting plan, which includes the assignment of all annexed land to wards, be approved as recommended.


NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TONTITOWN, ARKANSAS:


SECTION 1. That the ward redistricting plan, depicted on the map attached hereto and made a part hereof, be and is hereby adopted as the Official Ward Map for the City of Tontitown, Arkansas.

SECTION 2. That all previous ward maps and boundary descriptions associated therewith are hereby repealed.

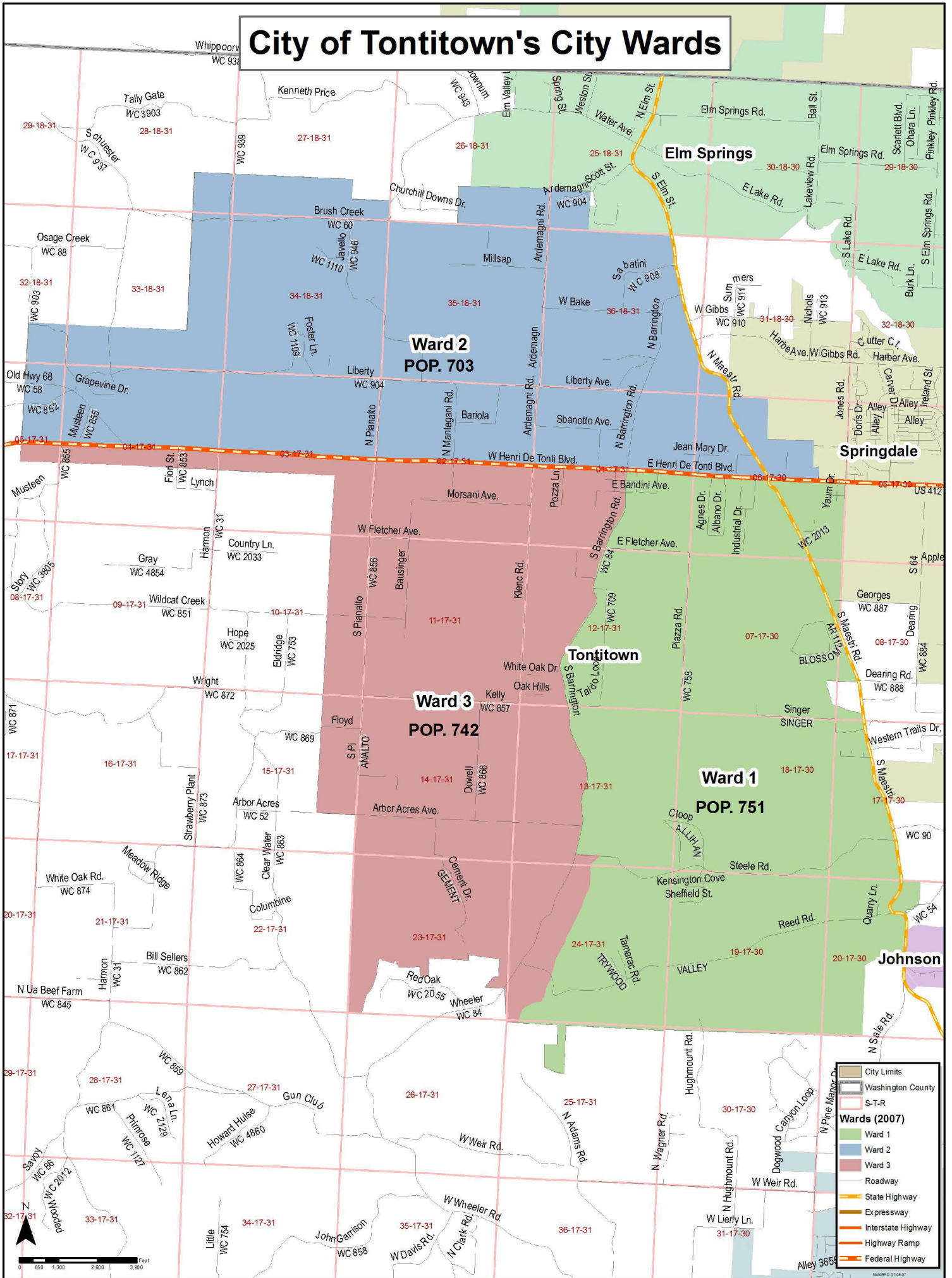
SECTION 3. That a duly certified copy of said Map shall be submitted to the Washington County Election Commission, and filed in the Office of the Washington County Clerk.

Washing County

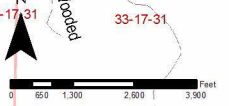
