ORDINANCE 2007-08-298

AN ORDINANCE AMENDING SECTION 150.20 OF THE TONTITOWN CODE OF ORDINANCES (REGARDING ADDRESSING); AND DECLARING AN EMERGENCY

WHEREAS, the Building Official, in cooperation with Washington County 9-1-1 officials, has determined that certain revisions to Tontitown addressing system are advisable; and

WHEREAS, in an effort to insure public safety, it is the desire of the mayor and city council that certain code amendments relative to addressing be approved and put into effect.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TONTITOWN, ARKANSAS:

SECTION 1. That Section 150.22 of the Code, under the heading Centerlines, is amended to read as follows: "Henri De Tonti Boulevard and its extension to the City of Tontitown's east and west planning area boundaries shall be the centerline street for north and south address numbers. Barrington Road and its intersection with Henri De Tonti Boulevard shall be the center point for east and west address numbers. The south sector thereof shall be divided by South Barrington Road extending to the southern planning area boundary. The north sector thereof shall be divided by North Barrington Road, and that part of North Maestri Road north of North Barrington Road."

SECTION 2. That the first sentence of Section 150.24 (B) of the Code, under the heading Address Numbers, is amended to read as follows: "In new residential subdivisions each standard sized lot shall be given a pre-assigned street number by the Building Official upon final plat approval."

SECTION 3. That the first sentence of Section 150.25 (E) of the Code, under the heading Signs, Numbers and System Maintenance, is amended to read as follows: "Replacement of address numbers is required within 15 days after written notice to the owner or occupant."

SECTION 4. Emergency Clause. The City Council hereby finds and determines that due to the urgent and immediate need to provide for proper addressing for public safety purposes, these amendments should be made effective immediately; as such, an emergency is hereby declared to exist, and this ordinance, being necessary for the

preservation of the peace, health, safety, and general welfare, shall be in full force and effect from and after its passage and approval.
