

ORDINANCE NO. <u>2007</u> -//-362

AN ORDINANCE PROVIDING FOR REMOVAL OF ELECTED OFFICERS FOUND TO BE GUILTY OF NONFEASANCE IN OFFICE AND FOR OTHER PURPOSES.

WHEREAS, Arkansas Code Annotated § 14-42-109, provides for the removal of a mayor, member of the city council or other appointive officer in cities of the second class when said person is found guilty of nonfeasance in office; and

WHEREAS, it is in the best interest of the City of Tontitown, Arkansas, to adopted the procedure set for in Arkansas Code Annotated §14-42-109 as an Ordinance of the City and to further provide for a manner in which the City Council may recommend a matter to the proper authorities for consideration under said statute;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TONTITOWN, ARKANSAS:

Section 1: If the mayor, member of the City Council, or any other elective officer of the city shall willfully and knowingly fail, refuse, or neglect to execute, or cause to be executed, any of the laws or ordinances within their jurisdiction, they shall be deemed guilty of nonfeasance in office as such term is used in Arkansas Code Annotated §14-42-109.

<u>Section 2:</u> If the City Council determines that the mayor, member of the City Council, or any elective officer has committed nonfeasance in office as defined herein, the City Council may by majority vote recommend the matter to the proper authorities for consideration pursuant to the procedures provided in Arkansas Code Annotated §14-42-109.

Section 3: If a judgment of record is entered removing the guilty officer from office, removal, replacement and/or reinstatement shall be in accordance with the procedure provided in Arkansas Code Annotated §14-42-109.
