A Resolution Allocating Funds for a Grant Application to the Arkansas Rural Development Commission for Lighting along the Harry Sbanotto Park Walking Trail

Whereas, the City of Tontitown supports the Health, Safety, Welfare and Quality of Life for its citizens and has constructed a Walking Trail in the Harry Sbanotto Park; and

Whereas, the City of Tontitown has presented plans to purchase and install Lighting for the Harry Sbanotto Park Walking Trail; and

Whereas, the City Council recognizes the need for the project; concurs its importance, and supports the City of Tontitown in its efforts to proceed with the same; and

Whereas, the City Council has determined that the City of Tontitown meets eligibility requirements necessary to apply for a grant under the Arkansas Rural Community Grant Programs; and

Whereas, the City Council authorizes the Mayor of Tontitown to apply for a grant on behalf of the City of Tontitown;

## THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TONTITOWN, ARKANSAS:

Section 1: The City Council of the City of Tontitown hereby appropriates \$15,000 to complete the local match for the purchase and installation of Trail Lighting in the Harry Sbanotto Park.

Be it further resolved, that the Mayor of Tontitown is hereby authorized to submit an application of formal request to the Arkansas Rural Development Commission for purposes of securing State grant funds in the amount of \$30,000 to aid and assist the City of Tontitown in executing the proposed project described herein and that the Recorder/Treasurer of the City of Tontitown is further authorized to administer the grant funds for the same project.
