## RE-ZONING ORDINANCE # 2010-03-352

AN ORDINANCE REZONING CERTAIN PROPERTY LOCATED at 335 N Barrington Road, FROM Zoning of R-3, TO C-2.

WHEREAS, after due notice as required by law, the Tontitown Planning Commission has heard all those who wish to be heard regarding a property owner rezoning application for certain property along Sbanotto Road, from R-3, to C-2; and

WHEREAS, the planning commission has recommended City Council approval of the application as submitted; and

WHEREAS, it is the desire of the City Council that said property be rezoned to C-2, as recommended by the planning commission.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TONTITOWN, ARKANSAS:

SECTION 1. That the following described property be, and the same is hereby rezoned from its current classification of R-3, to C-2, to wit, the property is more particularly described as Exhibit "A" to this Ordinance which is attached hereto and incorporated herein.

SECTION 2. That the Zoning Official shall cause the Official Zoning Map of the City of Tontitown to be amended to reflect this change within thirty (30) days of the date of this ordinance.


