## ORDINANCE 2011 - 04 -374

AN ORDINANCE REZONING CERTAIN PROPERTY ALONG the intersection of Barrington Road and Reed Valley Road FROM zoning of A-1 To R-1.

WHEREAS, after due notice as required by law, the Tontitown Planning Commission has heard all those who wish to be heard regarding a property owner rezoning application for certain property along the intersection of Barrington Road and Reed Valley Road from A-1 TO R-1; and

WHEREAS, the planning commission has recommended City Council approval of the application as submitted; and

WHEREASE, it is the desire of the City Council that said property be rezoned to R-1 as recommended by the planning commission.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TONTITOWN, ARKANSAS:

SECTION 1: That the following described property be, and the same is hereby rezoned from its current classification of A-1 to R-1, to wit:

A part of the NW1/4 of the SW1/4 of section 24, T17N, R31W in Washington County, Arkansas and being described as follows: commencing at the NE corner of said NW1/4, SW1/4 thence N87°13'06"W 471.49 feet to the centerline of Washington County Road #84 (south Barrington Road) thence along said centerline S27°29'43"W 68.48 feet, thence S33°44'30"W 74.69 feet,. thence S37°14'56"W 128.23 feet, thence S37°53'20"W 198.25 feet to the P.O.B., thence leaving said centerline S65°18'25"E 120.94 feet, thence S11°24'26"E 22.64 feet, thence S73°48.17"E 51.73 feet, thence S76°50'25"E 16.75 feet, thence S79°27'15"E 158.77 feet, thence S78°43'17"E 15.73 feet, thence S80°23'55"E 211.43 feet, thence S11°19'04"W 345.92 feet to the centerline of Washington County Road #893 (Reed Valley Road) thence along said centerline N74°46'33"W 71.05 feet, thence N75°22'40"W 200.44 feet, thence N74°46'15"W 225.52 feet, thence N74°19'02"W 151.83 feet, thence along a curve to the right 79.30 feet, said curve having a radius of 150.00 feet and a chord bearing and distance of N57°02'22"W 78.38 feet to the centerline of Washington County Road #84 (South Barrington Road) thence along said centerline N33°10'58"E 47.77 feet, thence N34°08'27"E 111.67 feet, thence N35°54'55"E 188.87 feet to the P.O.B.; containing 5.00 acres more of less subject to easement and right of way record.
