AN ORDINANCE REZONING CERTAIN PROPERTY ALONG Kissinger Road FROM zoning of A-1 To R-1.

WHEREAS, after due notice as required by law, the Tontitown Planning Commission has heard all those who wish to be heard regarding a property owner rezoning application for certain property along Kissinger Road from A-1 TO R-1; and
