ORDINANCE 20/2-11-400

AN ORDINANCE REZONING CERTAIN PROPERTY NORTH OF W. HENRI DE TONTI BOULEVARD, IN THE 2300 BLOCK, FROM R-3, RESIDENTIAL TO C-2, COMMERCIAL

WHEREAS, after due notice as required by law, the Tontitown Planning Commission has heard all those who wish to be heard regarding a property owner rezoning application for certain property north of W. Henri De Tonti Blvd., in the 2300 block, from R-3 TO C-2; and

WHEREAS, the planning commission has recommended City Council approval of the application as submitted; and

WHEREASE, it is the desire of the City Council that said property be rezoned to C-2 as recommended by the planning commission.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TONTITOWN, ARKANSAS:

SECTION 1: That all property currently zoned R-3 Residential contained in the following described tracts be, and the same is hereby rezoned to C-2, Commercial, to wit:
