BASEBALL FIELD

SCHEDULE OF USER FEES AND USE RESTRICTIONS

The City of Tontitown Baseball Field, located in Harry Sbanotto Park (the "baseball field" or the "field"), was constructed for the use and enjoyment of the citizens of the city of Tontitown, Arkansas (the "City"). In order to further this goal and to maintain the field for the years to come, the following fees and restrictions must be followed:

USE RESTRICTIONS:

- 1. Anyone wishing to use the baseball field for any sporting event must first make a reservation to do so by contacting the City's Administrative Office.
 - 2. All reservations must be paid in full and in advance.
 - 3. Reservations shall be made on a first-come, first-served basis.
 - 4. No refunds or rainchecks will be issued for any reason.
 - 5. All fees collected will be used for City Park maintenance only.
- 6. Only sporting events that are designed to be played on a baseball field shall be allowed. For example, kickball may be played on the field but soccer or football may not.
- 7. In order to prevent unnecessary damage to the field due to rain or otherwise, the City may close the field at any time and without notice.
 - 8. All fees shall be waived for little league or youth league team practices.

Fees:

- 1. Per Hour Ten dollars (\$10.00/hr).
 - Two (2) hour minimum;
 - Six (6) hour maximum.
- 2. Reoccurring Reservations Ten dollars (\$10.00) per session.
 - Limited to two (2) sessions per week;
 - Two (2) hour maximum;
 - Monday through Friday evening (5:00 p.m.-8:00 p.m.) sessions will be limited to one and one-half (1.5) hour sessions running from 5:00 p.m. until 6:30 p.m., and 6:30 p.m. until 8:00 p.m.

- The total fee for all sessions must be paid at the time the reservation is made.
