## CITY OF TONTITOWN, WASHINGTON COUNTY, ARKANSAS

AN ORDINANCE REZONING THE PROPERTY LOCATED ON ARDEMAGNI ROAD, – UNADDRESSED PROPERTY - Parcel # 830-37979-009 & 830-37983-000, THE CITY OF TONTITOWN ARKANSAS FROM A-1 AGRICULTURAL TO R-E RESIDENTIAL ESTATES

<u>Section 1</u>: The City of Tontitown hereby changes the zone classification from A-1 Agricultural to R-E Residential Estates for certain real property located at Ardemagni Road, Unaddressed Property Parcel # 830-37979-009 & 830-37983-000, located inside the City Limits of the City of Tontitown Arkansas, more particularly described as:

<u>Section 3</u>: That the Recorder-Treasurer shall cause this document, and any other documents needed to accomplish the intent of this ordinance, to be properly filed as required by law.
