§ 31.01 PLANNING COMMISSION.

(A) There is created a commission of the City of Tontitown, Arkansas, to be known as the Tontitown Planning Commission, which Commission shall consist of seven members, of whom at least two-thirds shall not hold any other municipal office or appointment except membership in the Board of Adjustment or a joint planning agency.

(B) The Planning Commission shall have all the duties and functions authorized by Act 186 of the Acts of Arkansas 1957, as amended.

(C) The members of the Planning Commission shall be named, appointed and confirmed by the City Council.

(D) The terms of the members of the Planning Commission shall be for three years. However, the initial appointment to the Commission shall be: three for one year, two for two years, and two for three years. The appointees shall draw for terms of office at the first meeting of the Commission. Thereafter as vacancies occur in the Commission, for whatever cause, the vacancies shall be filled in the same manner as the original appointments, and the appointees shall hold office until expiration of the term which they were appointed to fill. All members of the Planning Commission whose terms may expire shall serve until their successors in office have been appointed and confirmed by the City Council.

(E) The time for the regular meetings of the Planning Commission shall be on the fourth Tuesday of every month, beginning February 26, 2013, commencing at the time designated in the Planning Commissions Bylaws. If for any reason the City Council believes that city business requires the Planning Commission to meet twice a month, the City Council may, by motion approved by a majority of the Council members present, require the Planning Commission to meet twice a month. The Planning Commission Bylaws will be modified to reflect this requirement.

ORDINANCE NO. 552

AN ORDINANCE REPEALING ORDINANCE NO. 57 AND AMENDING ORDINANCE NOS. 2005-3-206, 2005-10-230, 2006-10-274, 2013-02-408; FOR THE CITY OF TONTITOWN, ARKANSAS AND FOR ESTABLISHING A PLANNING BOARD FOR THE CITY OF TONTITOWN, ARKANSAS, PRESCRIBING ITS DUTIES, AND DEFINING ITS POWERS.

WHEREAS, on or about January 7, 1975, the City Council for the City of Tontitown, Arkansas adopted Ordinance No. 57, and

WHEREAS, the voters of the City of Tontitown have passed an initiative desiring to repeal Ordinance No. 57 an amending Ordinance Nos. 2005-3-206, 2005-10-230, 2006-10-274, 2013-02-408 and have therefore directed the City Council to act upon their desires by repealing Ordinance No. 57 and amending Ordinances Nos. 2005-3-206, 2005-10-230, 2006-10-274, 2013-02-408 and Abolishing the Planning Commission and to establish a Planning Board.

BE IT ORDAINED by the City Council of the City of Tontitown, Arkansas:

1. Ordinance No. 57 and amending Ordinance Nos. 2005-3-206, 2005-10-230, 2006-10-274, 2013-02-408 is hereby repealed.
2. Section 31.01 of the Code of Ordinances for the City of Tontitown, Arkansas is hereby repealed and the following Section 31.01 is substituted in its place.

31.01 PLANNING BOARD

(A) There is created a board of the City of Tontitown, Arkansas, to be known as the Tontitown Planning Board which shall consist of five (5) members, of whom at least two-thirds shall not hold any other municipal office or appointment except membership in the Board of Adjustments or a joint planning agency.

(B) The Planning Board shall have all the duties and functions authorized by Act 186 of the Acts of Arkansas 1957 as amended.

(C) The members of the Planning Board shall be named, appointed and confirmed by the City Council. The first appointment of the Planning Board members shall be held on February 3, 2015; thereafter each calendar year the City Council will appoint each Planning Board member at the February Council meeting.

(D) The terms of the members of the Planning Board shall be for one year and running for the calendar year. Thereafter as vacancies occur in the Board, for whatever cause, the vacancies, shall be filled in the same manner as the original appointments, and the appointees shall hold office until expiration of the term which they were appointed to fill. All members of the Planning Board whose terms may expire shall serve until their successors in office have been appointed and confirmed by the City Council.

(E) The time for the regular meetings of the Planning Board shall be on the fourth Tuesday of every month, beginning February 24, 2015, commencing at the time designated in the Planning Board Bylaws. If for any reason the City Council believes that city business requires the Planning Board to meet twice a month, the City Council may, by motion approved by a majority of the Council members present, require the Planning Board to meet twice a month. The Planning Board Bylaws will be modified to reflect this requirement.
