

RESOLUTION NO. 2018- 08-799R

CITY OF TONTITOWN, WASHINGTON COUNTY, ARKANSAS

A RESOLUTION AUTHORIZING THE MAYOR OF THE CITY OF TONTITOWN TO ACCEPT A BID FROM AND ENTER INTO AN AGREEMENT WITH ROSETTA CONSTRUCTION, LLC FOR THE HIGHWAY 412 WATER TRANSMISSION LINE AND IMPROVEMENTS .

WHEREAS, the City Council of the City of Tontitown has determined that betterments and improvements to the water facilities should be made in order that the City and its inhabitants may have adequate and proper water facilities;

WHEREAS, in furtherance of these betterments and improvements, the City of Tontitown has authorized the undertaking of a project to consist of the installation of an 18' water transmission line that would need to be approximately seven (7) miles long and would run west alongside Highway 412 to connect to a two (2) Ton water service;

WHEREAS, the Mayor and City Council of the City of Tontitown, in accordance with state law, advertised for bids from contractors interested in performing said engineering services and received many qualified candidates;


WHEREAS, the lowest and best bid was submitted by Rosetta Construction, LLC for \$7,996,516.00 and the City Council for the City of Tontitown desires that the Mayor accept this bid and proceed with an agreement with Rosetta Construction, LLC as the City Council finds that they are the best qualified to provide engineering services for this project; and

WHEREAS, the City engineer, Garver USA, LLC recommends that this bid of Rosetta Construction, LLC, be accepted by the City and that the City Council authorizes the Mayor of the City of Tontitown to accept this bid and enter into an Agreement for Engineering Services.

NOW, THEREFORE, BE IT RESOLVED, that in connection with the selection of Rosetta Construction as the lowest bid and best qualified to provide engineering services for the project, the Mayor of Tontitown, Arkansas, on behalf of the City of Tontitown, Arkansas, is authorized to accept this bid and enter into an Agreement for Engineering Services (the "Agreement") with Rosetta Construction, LLC for the water tower project.

Bids were opened for the referenced project at the City of Tontitown at 2:30 p.m. on Tuesday, July 31, 2018. The bids have been checked for accuracy and for compliance with the contract documents. A summary and detailed tabulation of the bids received is enclosed with this letter.

A total of 9 (nine) bids were received on the project. Rosetta Construction submitted the low bid for the project in the amount of \$7,996,516.00. Attached are the bid documents submitted by the low bid, generally including the bid form, subcontractors, bid bond, and qualifications. Per attached qualifications, Garver and the City of Tontitown staff have experience working with the low bidder on several projects, and Rosetta Construction is qualified to perform the work.

We believe that the bid submitted by Rosetta Construction represents a good value for the City of Tontitown. We recommend that the construction contract for the Highway 412 Water Transmission Line Improvements be awarded to Rosetta Construction.
