Bids were opened for the referenced project at the City of Tontitown at 2:00 p.m. on Thursday, October 4, 2018. The bids have been checked for accuracy and for compliance with the contract documents. A detailed tabulation of the bids received and bid documents received by the low bidder (generally including the Bid Form, Bid Bond, and Qualifications) are enclosed with this letter.

A total of eight bids were received on the project. Brothers Construction, Inc. of Van Buren, Arkansas submitted the low bid for the project in the amount of \$499,460. Brothers Construction also plans to open a new office in the City of Tontitown.

We believe that the bid submitted by Brothers Construction represents a good value for the City of Tontitown. We recommend that the construction contract for the Highway 412 Bypass Gravity Sewer Extensions be awarded to Brothers Construction, and we recommend not accepting the deductive alternate (reduction in the bid amount of \$74,892 by eliminating approximately 1,400 feet of gravity sewer, or eastern extension to Liberty Avenue).


