

RESOLUTION NO. 2006-05-131

A RESOLUTION PROVIDING FOR THE PUBLISHING OR POSTING OF BYLAWS AND ORDINANCES FOR THE CITY OF TONTITOWN, ARKANSAS.

WHEREAS, Arkansas Code Annotated 14-55-206 governs and sets forth the procedure that municipalities shall follow in the publishing or posting of bylaws and ordinances, and

WHEREAS, it is the finding of the conclusion of the City Council that the bylaws and ordinances of the City of Tontitown, Arkansas, shall be published or posted in accordance with state law.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TONTITOWN, ARKANSAS, AS FOLLOWS:

Section 1: This Resolution shall be known as the Publishing or Posting Resolution for the City of Tontitown, Arkansas, and that all bylaws and ordinances of that City of Tontitown, Arkansas, shall be published or Posted in accordance with A.C.A. 14-55-206..



Section 3: The City Council furthers directs that this Resolution be set forth word for word in the Minutes of the May 10th 2006 Meeting of the Tontitown City Council..


