## AN ORDINANCE REZONING PROPERTY LOCATED ON MILLSAP RD PARCEL NO. 830-37979-003, THE CITY OF TONTITOWN ARKANSAS FROM A, AGRICULTURE TO R-E, ESTATE SINGLE-FAMILY

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the city of Tontitown, Arkansas:

<u>Section 1</u>: The City of Tontitown hereby changes the zone classification from A, Agriculture to R-E, Estate Single-Family, for certain real property located on Millsap Rd- Parcel No. 830-37979-003, located inside the City Limits of the City of Tontitown Arkansas, more particularly described as:

Commencing at the Northeast Corner of said Section 35, a record corner; thence South 03'08'50" West, a distance of 329.93 feet; thence 87'20'12" West, a distance of 892.10 feet for the POINT OF BEGINNING; thence South 02'19'58" West, a distance of 986.84 feet; thence North 87'40'00" West, a distance of 233.74 feet and from which a set 5/8" rebar pin bears North 02'37'50" East, a distance of 18.21 feet; thence North 02'37'50" East, a distance of 500.00 feet to a set 5/8" rebar pin; thence North 87'40'00" West, a distance of 200.00 feet to a set 5/8" rebar pin; thence North 02'37'50" East, a distance of 489.33 feet; thence South 87'20'12" East, a distance of 428.60 feet to the POINT OF BEGINNING.
