Terms and Conditions: The parties to this Irrevocable Letter of Credit acknowledge that it cannot be revoked by the Lender during the term of the Letter of Credit as is described above; that it may be partially released annually based on the electrical usage of qualified services constructed and connected to the electrical system as is described in the Commercial Development Installation Agreement dated the day of December, 2019. upon Lender's honor of sight drafts presented by the Beneficiary, the Lender shall be fully discharged to the extent of any payment made upon any partial sight draft and, in the event of full payment by the Lender of the full amount of this Irrevocable Letter of Credit, the Lender shall be fully discharged.
