CITY OF TONTITOWN, WASHINGTON COUNTY, ARKANSAS

A RESOLUTION AUTHORIZING THE FILING OF AN APPLICATION WITH THE NORTHWEST ARKANSAS REGIONAL PLANNING COMMISSION FOR FEDERAL-AID SURFACE TRANSPORTATION BLOCK GRANT PROGRAM – ATTRIBUTABLE FUNDS TO SIGNALIZE THE INTERSECTION OF U.S. 412 AND KLENC ROAD

WHEREAS, at the request of the City of Tontitown, the Arkansas Department of Transportation (“ArDOT”) has conducted a traffic operations study, including a 24-hour turning movement count and an on-site investigation, of the intersection of U.S. 412 and Klenc Road; and

WHEREAS, said study concluded that the intersection meets the warrants as outlined in the Manual on Uniform Traffic Control Devices, for a traffic signal; and

WHEREAS, the cost of signalizing this intersection, which is of regional significance due to it being on the primary route to the region’s only landfill, requires assistance beyond which is currently available to the City; and

WHEREAS, under ArDOT policy, federal-aid funding requests for such projects located within the Adjusted Urbanized Area for the Northwest Arkansas Regional Transportation Study Transportation Management Area (“TMA”) are to be referred to the Northwest Arkansas Regional Planning Commission (“NWARPC”) for consideration; and

WHEREAS, it is the desire of the City to seek federal Surface Transportation Block Grant Program-Attributable (“STBGP-A”) funding through the Northwest Arkansas Regional Planning Commission to prepare and effectuate the project to completion; and

WHEREAS, the City understands its obligation to provide matching funds in the amount of 20% of total project costs; that assistance would be on a reimbursable basis, requiring work to be accomplished and proof of payment prior to actual monetary reimbursement; and that there would be no reimbursement for any work accomplished prior to issuance of an official notice to proceed by ArDOT.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TONTITOWN, ARKANSAS:


SECTION 1. The Mayor is hereby authorized and directed to file an application with the NWARPC for \$360,000 in federal STBGP-A funds to prepare and implement a project to signalize the intersection of U.S. 412 and Klenc Road.

SECTION 2. The City agrees to comply with all federal grant and state requirements, and to provide local matching funds in the amount of \$90,000.


SECTION 3. The Mayor is hereby authorized and directed to execute all necessary and appropriate agreements and contracts necessary to effectuate the project.
