To Whom It May Concern:

A.C.A. § 26-26-402 (Procedure for adjustment of taxes after reappraisal or reassessment of property) states that whenever a countywide reappraisal or reassessment of property subject to ad valorem taxes...shall result in an increase in the aggregate value of taxable real and personal property in any taxing unit in this state of ten percent (10%) or more over the previous year, the rate of city or town, county, school district, and community college district taxes levied against the taxable real and personal property of each taxing unit shall, upon completion of the reappraisal or reassessment, be adjusted or rolled back by the governing body of the taxing unit for the year for which levied as provided. The adjustment or rollback of tax rates or millage for the base year shall be designed to assure that each taxing unit will receive an amount of tax revenue from each tax source no greater than ten percent (10%) above revenues received during the previous year from each tax source.

Washington County has completed the 2020 county-wide reappraisal and based on the taxable value increases in your jurisdiction when performing the Base Year Millage Rollback Computations it has been determined that your taxing jurisdiction will need to rollback their respective millage rate for 2020 (please see below):

Taxing Jurisdiction: Tontitown City
Taxable Value Increase: 12.74%
Current Millage Rate: 3.5 mills
New Rollback Millage Rate: 3.4 mills
Amount of Millage Rollback: 0.1 mills

Attached is the Base Year Millage Rollback Computation and Certification Form for your jurisdiction. This form shows how the amount of rollback was calculated. This form shall be signed by the officers of your taxing jurisdiction's governing body and returned to the Washington County Clerk's office on or before the third Monday in November of the base year (11/15/2020).
