f) Discussion of Bond Extension Election for Water/Sewer Projects –Colvin

The city has a 500,000 gallon water tank but more water storage and water/sewer lines are needed for future growth. The city passed a 1 cent sale tax in 2013 this bond will pay off in 2032 (approximate payoff is 3.2 million) However, this tax will never go away. The mayor discussed with the council a way the city can borrow the extra funds, approximately 6.8 million up to 14 million, at the current low interest rate of approximately 2.5 percent with

no tax increase to the citizens, just a new payoff year of 2046 to 2048. This would allow the city start these projects that are needed. There would be a special election and the citizens would have to vote.
