10. New Business

- a) Discussion of Tontitown/Washington Water Authority Service Boundary –Colvin The city of Tontitown and Washington County Water Authority have been discussing extending Tontitown's service area. Tontitown's water lines are available and can service the extended area.
- b) Discussion of Klenc Road Water Line Cost Share -Colvin

The city of Tontitown has requested that Solomon Properties adjust their plans to the Hickory Meadows development and connect the subdivision to the 8" waterline that is ½ a mile south on Klenc Road rather than where they had planned to connect the line on Kelley Road which is only ¼ mile away. This request will change the length of the line form 1350' to 2750'. The original 1350' of 8"water line cost estimate was \$76,250.00 with 2 hydrants. The new estimate is \$196,500.00 with 5 hydrants, driveway crossing and road boring. The city's cost share estimate would be \$120,250.00. The city feels this would be helpful for future development along Klenc Road and less expensive to do it now.

c) Discussion of Mercantile Building Cost Share -Colvin

The city is trying to negotiate a cost share agreement with the property owner for a sewer line/hookup.

d) Discussion of Bond Extension Election -Colvin

This was discussed at the last C.O.W. meeting

The city passed a 1 cent sale tax in 2013 this bond will pay off in 2032 (approximate payoff is 3.2 million) However, this tax will never go away. The mayor discussed with the council a way the city can borrow the extra funds, approximately 6.8 million up to 14 million, at the current low interest rate of approximately 2.5 percent with no tax increase to the citizens, just a new payoff year of 2046 to 2048. This would allow the city start these projects that are needed. There would be a special election and the citizens would have to vote.
