B. Discussion of a Resolution Adopting premium pay for certain municipal employees from the American Rescue Plan – Colvin

The city received approximately \$450,000.00 in ARPA funds and another \$450,000.00 is scheduled for January 2022 and an additional \$1,100.00 other cities didn't ask for. The mayor attended classes with the Arkansas Municipal League on how to spend this money. Currently the funds are to be spent on Water/Sewer and Drainage Infrastructure projects. The Federal Government is allowing for all the cities in NW Arkansas to adopt this resolution for Premium pay for their city employees. This resolution is copied from City of Farmington which was pasted by Lincoln, Springdale, and Prairie Grove and since we never shut our city down and the mayor is asking the council to adopt this resolution, and to pay the full-time city employees who qualify \$2,500.00 per employee, in lu of a Holiday bonus, for providing essential work during the covid pandemic. One city museum employee is disqualified because she was furloughed.

Full Time = January 1, 2021, through September 30, 2021, and is still employed at passage.

One update in Section 2 of the resolution – Add language "and currently employed".

The mayor said the council should have been received a packet from the Legislative Audit for the last 2 years and it is a requirement of the mayor to make that announcement at a council meeting. The city passed with flying colors, except for two and those findings are on the mayor.

- 2) The mayor spent tax dollars on a tent and chairs for Tommy Granata's Funeral which the mayor explained it was the height of Covid and Tommy was a former mayor of Tontitown, and the church couldn't hold it.

The Ozark Catholic Academy had an auction and raised \$40,000.00 to put towards broadband for the school.

Congratulations, the Bond Issue passed with 86%. The mayor said he was so proud of the council and all the city employees for handing out flyers and educating the citizens on what the city was trying do for them and future growth.

The city is working on a one-story Fire Department building design, with no administration office. With extra money saved the city could remodel the old Fire Department and that could be the administration office. A committee has been formed to assist with the design of the administration office that will house the Fire Marshall, Inspections Department, and Building Officials.
