- 7. Proclamation for Mrs. Betty Hinshaw The mayor read aloud the following proclamation:

PROCLAMATION CITY OF TONTITOWN, WASHINGTON COUNTY, ARKANSAS

WHEREAS, Elizabeth Byron Brockmeyer was born May 17, 1925, in St. Louis, Mo., the first child of Edwin John de Nomy Brockmeyer and Mildred Wildberger Pauls Brockmeyer; and

WHEREAS, her father fostered a love of nature by often taking Betty and her sister, Sue, fishing and camping on the Gasconade River when they were young, instilling the belief that they should "leave a place better than they found it"; and **WHEREAS,** she graduated from Washington University in 1946 with an English degree and went to work for Ralston Purina Co., where she met her future husband, Jerrold Eldon Hinshaw; and

WHEREAS, Betty Brockmeyer and Jerry Hinshaw married in 1949 and remained together for 54 years, until his death, raising four children - Anita, known as Sunny, Cathy, Ross and Dawn; and

WHEREAS, the couple moved from St. Louis, to Jacksonville, Florida, and Dallas, Texas, before finding their true home in Tontitown, Arkansas in 1956; and

WHEREAS, they established a cattle ranch south of Tontitown called Rocking Chair Ranch, building a house on a hill with a beautiful view of the valley below and a lake where many people enjoy fishing; and

WHEREAS, Ms. Betty was a proud homemaker and community volunteer in a multitude of settings, including with the Girl Scouts, at her childrens' schools, with the Harmony Homemakers Extension Club, Shiloh Museum, Springdale Public Library, and with the Washington County Fair where in 1980 she instigated a popular photography exhibition that continues today; and

WHEREAS, she has been a loving encourager to each member of her family, supporting them in failure as well as success, and showing pride in their education, work, pursuits and ambitions; and

WHEREAS, she is devoted to the First United Methodist Church of Springdale, where she remains active, is guided by the Christian belief in stewardship and at 97 is the oldest serving member; and

WHEREAS, she has always enjoyed watching and identifying birds in her yard and at her lake, inspiring her in 2022 to establish an enduring legacy in the 25-acre Betty Hinshaw Bird Sanctuary, a nature preserve in Tontitown that she hopes will help protect the environment and allow others to experience joy in the Earth's beauty; and

WHEREAS, for the reasons set forth above, the City of Tontitown wishes to honor and recognize Betty Henshaw for her service to the community by officially declaring June 2, 2022 to be known as "Betty Hinshaw Day".
