

5. Comments from Citizens

Tontitown City Attorney Justin Echimann explained the appeal process to the council. The Planning Commission denied this request so the appilcant went through the appeals process in hopes the council will overturn the Plannings Commission's decision.

Tom Hennlly with Crafton Tull Engineering spoke on behalf of the owners and would answer any questions the council may have.

Tina McDonald (952 Foster Lane) said she is impacted by the water more than anybody and is one of the sellers of the property and realizes ajustments will need to be made for the water which most of the water comes through the valley from 412. Mrs. McDonald, said whatever the engineer does, will make it better than what it is now, and this rezoning should be passsed, the lot sizes will look better, and she would love to see a neighborhood there.

Clint Penzo with ReMax and is the realtor for this property said the future zoning for that area is medium density and the runoff is probably going to be improved when the detention or retention ponds are put in place. And if the future plan is for that area is to be medium density, he doesn't see why low-density rezoning would be a problem. Mr. Penzo asked that the council go with the future plans for that area.

Logan Geels (2151 Liberty) said the 100-year floods are happeing every 2 years and the water makes the roads impassable and is against it for runoff reasons, roads, and safety issues.

Kevin Boortz, Vice Chairman for the Planning Commission read aloud the below letter from Josh Craine who was unable to attend tonight's meeting and who is also on the Planning Commission.

Council-

I would like to comment on the Liberty Rezoning Appeal. I will not be able to attend tonight's meeting due to scheduling conflicts, but feel this is too important of a topic to remain silent on. As everyone is well aware, Tontitown has a serious infrastructure issue pertaining to roads that needs to be addressed. Members of the planning commission, as well as citizens, have been echoing these concerns for months. Up until now, we as a city have failed to meet this problem head on. In my opinion, it is the planning commissions responsibility to plan for the well-being of the community and its citizens. We have doubled in population in the last couple years. That means twice as many cars on the road in our city. Increasing density BEFORE we have a way to fund the road infrastructure that our city desperately needs is premature and irresponsible to our community. The planning commission is now starting to see and understand this issue. We have been diligently brainstorming various avenues to try and accommodate the, some would say, unprecedented growth in our area. Increasing density is not the answer, not right now. As always, the planning commission looks forward to working hand in hand with city council to make Tontitown a better place to live.

I respectfully ask this council to uphold the planning commission's UNANIMOUS vote to DENY this rezoning request.
