1. Bariloche Planned Unit Development and Preliminary Subdivision Plat: The applicant is requesting plat approval for 154 lots: 151 single-family, 2 detention, and 1 common area, on 40.13 acres. The project is located on Klenc Road, approximately 3,300 south of Hwy 412/W. Henri de Tonti Blvd., on parcel #'s 830-37758-000 and 830-37758-001.

The applicant is requesting a Planned Unit Development and Preliminary Subdivision Plat approval for the Bariloche Subdivision. The 40.13-acre property is located within the City limits of Tontitown, along the west side of Klenc Road, and approximately 3,300 feet south of Hwy. 412 / W. Henri de Tonti Blvd intersection. This property is owned by Infas Corporation, Inc. The applicant has submitted plans proposing to connect to the available stub out to the south and will need to provide additional stub outs to the north as it is an undeveloped property. The site is currently undeveloped and is used primarily as pastureland.

2. <u>Variance 1710 Arbor Acres Ave:</u> The applicant is requesting a variance at 1710 Arbor Acres Ave. to allow a proposed barn structure to be setback on the west side of the property six (6) feet instead of the required thirty (30) feet. This site is located on parcel 830-38352-100.

At the applicants request possibly look at a setback of 10 or 20 feet instead of the 6 feet, regardless it's still a 30-foot setback.
