WHEREAS, the City of Tontitown received pricing from a cooperative purchasing agent as authorized by Ark. Code § 19-11-249 for one (1) Caterpillar Skid Steer Loader from Riggs Equipment in the amount of approximately \$86,334.07; and

WHEREAS, the City desires to execute the purchase of one (1) Caterpillar Skid Steer Loader from Riggs Equipment in order to provide reliable equipment for the safety and welfare of the citizens of Tontitown; and

WHEREAS, the City Council has determined it is in the best interest of the City of Tontitown and its citizens to provide funding in the amount of approximately \$86,334.07 for the purchase of one (1) Caterpillar Skid Steer Loader from Riggs Equipment, and to waive competitive bidding for the same.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Tontitown, Arkansas:


