## CITY OF TONTITOWN, WASHINGTON COUNTY, ARKANSAS

RESOLUTION WAIVING **COMPETITIVE BIDDING** AND AUTHORIZING THE PURCHASE OF ONE (1) 2022 DODGE RAM 1500 SSV CREW CAB 4X4 FROM SUPERIOR DODGE CHRYSLER JEEP RAM OF NORTHWEST ARKANSAS FOR THE CITY OF TONTITOWN, ARKANSAS.

WHEREAS, the City of Tontitown received a quote for one (1) 2022 Dodge Ram 1500 SSV Crew Cab 4x4 from Superior Dodge Chrysler Jeep Ram of Northwest Arkansas in the amount of approximately \$42,545.00 for the Tontitown Police Department; and
