**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Tontitown Arkansas:

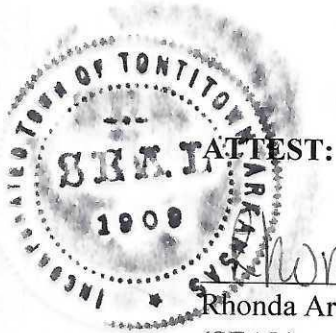

**Section 2.** All part-time employees are not included in this bonus and the 2022 budget is amended accordingly.


